- Format:** **Folk style** with use of flip charts (no bullpen) **All IKWF rules apply**
 Tot, Bantam and Intermediate - 4 man round robin. Periods (1-1-1 minute) wrestled on ½ mats
 Novice & Senior - 4 man round robin. Periods (1-1 ½-1 ½ minutes) wrestled on full mats
- Awards:** **Medals for 1st - 4th Place**
- Weigh-Ins:** Saturday, January 7th, 6:15-7:45am in the Blackhawk Center
- Entry Fee:** \$15 per wrestler (non-refundable)
400 wrestler maximum / No walk-ins at the door
